Understanding the Administrator's Quarterly Compliance Report

Clause B81 of the Addendum to the National Health Reform Agreement 2020-21 to 2024-25 (the Addendum) requires the Administrator to publish details of Commonwealth, State and Territory compliance with the data requirements specified in the Administrator's Three-Year Data Plan 2024-25 to 2026-27.

Clause A152 of the Addendum requires the Administrator to publish additional information in the compliance reports on dates data is submitted or resubmitted by States.

The format of the Quarterly Compliance Report follows a standard structure, with relevant data requirements reflected in each quarter. Further information on requirements can be found in the Administrator's 2024-25 Data Compliance Policy.

Executive Summary

2024-25 Service Agreements

Six out of eight States submitted all 2024-25 Service Agreements to the Administrator, with NSW and Vic providing partial submissions.

119 of 135 service agreements have been submitted to the Administrator.

- Of the **119** service agreements submitted, **37** were provided to the Administrator within the required 14 calendar days from finalisation or amendment.
- Of the **86** ABF LHN Service Agreements provided, **79** align to activity estimate submissions, compared to **31** out of **95** in December 2024.
- Qld, ACT and NT reported out-of-scope activity and out-of-scope funding in the Service Agreements; and
- Three out of eight States reported a State Price (or NEP) in the Service Agreements.

Timely submissions of service agreements are important to accurately calculating Commonwealth entitlements and issuing Payment Advice throughout the year.

Due to the timing of requested estimate updates from States and Territories for the May 2025 Payment Advice, compliance has been assessed on activity estimates used for the February 2025 Payment Advice. Updates received since then will be incorporated into the June 2025 Quarterly Compliance Report.

2024-25 Quarter 2 NHR Data Submissions

With respect to the timeliness of **Submission A**, seven out of eight States provided their data on time by 31 March 2025, with WA submitting all activity by 1 April 2025. **Submission B** was provided by seven of eight States by 31 March 2025, with Queensland submitting on 1 April 2025.

SA and the ACT had no **Sentinel Events** to report for the quarter.

Leave and Hospital in the Home Care (L/HITH) national best endeavours data set is to capture periods of formal absences from care facilities within episodes of admitted patient care. This is required to be submitted each quarter. In Q1 2024-25, no States submitted this data set. In Q2, only Queensland provided a submission.

Seven out of **eight** States provided the **Statements of Assurance** on time with NSW submitting on 3 April 2025. The Commonwealth provided MBS/PBS data on time, and the accompanying Statement of Assurance on 1 April 2025.

Data Resubmissions

The Statement of Assurance accompanying the initial submission should flag the need for any resubmissions, including commentary on the reasons why this should be necessary. The Administrator will make a note of such requests and respond in writing to the relevant jurisdiction. States are reminded that any resubmissions should be accompanied by an updated Statement of Assurance that aligns with the previous Statement.

If it becomes necessary to request a resubmission where one has not been flagged in the initial Statement of Assurance, the authorising officer of the initial Statement should write to nhfa.Administrator@nhfa.gov.au and data@nhfb.gov.au requesting a resubmission, including commentary on why this should be necessary.

Tas was the only State to flag a resubmission in the initial Statement of Assurance as well as provide a Statement of Assurance with the data resubmission received on 14 April 2025.

Monthly Financial Reporting

All monthly financial reports were completed by States on or before the due date of the 12th of the following month.

Maintenance of Effort

Under the Addendum (A102), Parties agree to, at a minimum for the period of 2020-21 to 2024-25, maintain 2018-19 levels of funding for Public Hospital Services through the National Health Funding Pool (the Pool), while having regard to new, appropriate models of care that may change the setting in which care is delivered.

The Administrator's Annual Report 2023-24 - Maintenance of Effort was published on 10 April 2025 at <u>publichospitalfunding.gov.au/publications</u> following collaboration between the Administrator, the NHFB and all jurisdictions to improve the consistency and transparency of reporting.

Determinations, and final activity and entitlements – A153 report

Under the *National Health Reform Agreement 2020-21 to 2024-25* (the Addendum), the Administrator will ensure that determinations, and final activity and entitlements at the Local Hospital Network level, are publicly available for all years that the Addendum has been in operation (A153). The report will be published following the 2024-25 Annual Reconciliation.

2024-25 Service Agreement Provision Timeline


