Quarterly Compliance Report



Understanding the Administrator's Quarterly Compliance Report

Clause B102 of the National Health Reform Agreement 2011 (NHR Agreement) requires the Administrator to publish details of Commonwealth, State and Territory compliance with the data requirements specified in the Administrator's Three Year Data Plan 2022-23 to 2024-25. Clause A152 of the Addendum to the National Health Reform Agreement 2020-21 to 2024-25 (the Addendum) requires the Administrator to publish additional information in the compliance reports on dates data submitted or resubmitted by States.

The format of the Quarterly Compliance Reports follows a standard structure, with relevant data requirements reflected in each quarter. Further information on requirements can be found in the *Administrator's 2022-23 Data Compliance Policy*.

Executive Summary

2022-23 Service Agreements

Following engagement with States and Territories on consistency and transparency of public hospital funding, 33 of the 47 Service Agreements submitted to the Administrator align to current data estimate submissions. Queensland have confirmed they are currently updating their Service Agreements and will provide to the Administrator in the coming weeks, noting that at present the Service Agreement activity data does not align with activity estimates provided.

As at 5 February 2023, seven months into the 2022-23 Financial Year, Victoria has not provided any 2022-23 Service Agreements to the Administrator. This is the fourth year of delays in Victoria's Service Agreements;

- 2019-20 Service Agreements were provided in November 2019
- 2020-21 Service Agreements were provided after the financial year concluded
- 2021-22 Service Agreements were provided in May 2022.

National Health Reform Data submissions

Timeliness of data submissions to support the 2021-22 Annual Reconciliation has improved on the previous year with all eight States and Territories providing Submission A files, Submission B files and Statements of Assurance on time.

With respect to the timeliness of data for the first quarter of 2022-23, all eight States and Territories provided their data ahead of the due date compared to seven in 2021-22.

Monthly Reporting

Monthly reporting continues to be completed by States and Territories on or before the due date of the 15th of the following month (with the December due date extended to 18 January 2023 to take account of end of year shut-down).

Consistency and Transparency

The Administrator has been working with States and Territories on achieving greater transparency and consistency of public reporting, including through the Quarterly Compliance Report. This is of particular importance in assessing Maintenance of Effort as required under the Addendum to the National Health Reform Agreement.


